1. Applications for Full and Family Full Memberships must be accompanied by a FULLY COMPLETED Boat Card indicating FULL COMPLIANCE with ALL Compulsory Safety Equipment requirements, with a 6X4 COLOR PHOTO of the Boat, attached.
(Reworked cards from previous owner will not be accepted).
2. Applications without these documents will be processed as an Application for Social Membership.
3. Full Membership will be reconsidered on receipt of the documents requested.
4. Any Social member acquiring a boat must upgrade to a Full or Family Full member and advise the club by completing the above form.
5. A copy of the Lae Yacht Club Marina Handbook containing all the necessary club rules and regulations will be handed to you once membership has been approved.
6. Cheque Cashing and Boat Launching Facilities will not be available until your Application has been approved by the Committee.
7. Any number of Full Members may attach to a boat, however, voting at the Annual General Meeting of the Club is restricted to two (2).
8. A boat must be in charge of a Full member at all times when in use.
9. Companies owning boats must declare all employees eligible to be skippers of their boat and must become Full or Family Full members.

I, _____, being the owner of the boat named above, having read all the Regulations, By-Laws and Safety Requirements (Club Rules) of the Lae Yacht Club Incorporated do agree to comply with the said Club Rules, as amended from time to time. I agree, at all times, to maintain the Safety Equipment on my boat to a standard, equal to or greater than the minimum standard required. I agree to pay promptly any fees levied by the Office & Management of the Club in accordance with the Club Rules, as amended from time to time. I understand that fines are credited only to the Club's Search & Rescue Fund. I acknowledge that as an owner of the boat, I have sole responsibility for its safety and the safety of its occupants, whilst under my control at sea.
